

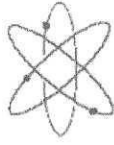
MEMBERSHIP APPLICATION PROCESS

The process for applying for membership in Richland Kennel Club:

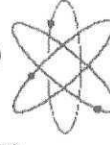
- Membership application needs to be filled out completely and returned either at a meeting in person, or submitted via email to Richlandkc386@gmail.com
 - During the time that we are having ZOOM meetings, you will be invited to attend after your application has been received
 - General meetings are held the first Thursday of each month at 7:30, unless we have a social gathering planned
- Club members will sign the application at the bottom after it is returned
- Candidate for membership must attend a meeting before the application can be read
- Reading of the application process:
 - Application is read at a general meeting
 - Application is read and reviewed at board meeting and board makes motion to return it for approval to the general club membership
 - Application is voted on at the next general meeting for acceptance in the club, if the dues have been paid.
 - Dues are \$15 for individual and \$25 for a family application

- Dues run from January through December, for those members joining in October through December, their dues will apply for the following year.

CONSTITUTION ARTICLE I

NAME AND OBJECTIVES

- Section 1. The name of the Club shall be the Richland Kennel Club, Inc.

 - c. To conduct sanctioned matches, dog shows and obedience trials under the rules of the American Kennel Club.
- Section 3. The Club shall not be conducted or operated for profit and no part of any profits or remainder or residue from dues or donations to the Club shall enure to the benefit of any member or individual.
- Section 4. The members of the Club shall adopt and may from time to time revise such bylaws as may be required to carry out these objects.
